As such, information on third- party providers, screened for quality control, will be made available to all members. Every effort will be made to find qualified providers.

A primary function of **At Home** in Newbury, New London, Springfield, Sunapee, Sutton and Wilmot is to respond to members' requests in a timely manner and to determine member satisfaction. Members will usually contract directly with the third-party providers; however, **At Home** in Newbury, New London, Springfield, Sunapee, Sutton and Wilmot will not assume any direct or indirect responsibility or liability for contracted work.

Annual yearly membership is \$300 for individuals and \$450 for any two persons living in the same household. Each additional household member's rate is \$150. Membership begins on the first day of the month after your payment is received and will continue for the next eleven consecutive months. As a member, you are entitled to all the benefits of membership.
